Beginning Jan. 1, 2017, the Center for Rural Entrepreneurship (CRE) is operating under the umbrella of <u>Virginia Community</u> <u>Capital</u> (VCC) to launch a new **national** initiative focused on *direct investing for good*, aka impact investing. This new partnership will bring VCC's 10 years of mission-aligned investing expertise in Virginia, together with CRE's 15 years of nationwide entrepreneurial development and community development philanthropy expertise to help communities and place-focused foundations use more of their assets to advance local prosperity.

While there are important changes coming, our relationships will not change. We will continue to work with our placebased partners to build entrepreneurial communities and with the <u>Aspen Institute Community Strategies Group</u> to advance community development philanthropy. At the same time, we will be teaming with Teri Lovelace at VCC to realize our emerging vision of this new national direct mission-related investing initiative for place-focused foundations. Much of our current work is strategically aligned with this new initiative, which is what makes it so exciting for us! Ultimately, we believe that this partnership will bring new resources that we can share. And, we are convinced that this partnership will enable us to continue and deepen CRE's work for years to come.
